



# PARTICIPANT RELEASE & WAIVER

1. I understand that my execution of this Waiver is a prerequisite for my child/guest's participation in KIDS BLOCK PARTY events and activities.
  2. I understand that in order to be allowed to participate in the events/activities, I agree to assume all risks and to release and hold harmless Spectra Venue Management and the Saint Charles Convention Center, its past and present affiliates, assigns, successors in interest, agents, servants, employees, volunteers, officers, directors and sponsors, and all government and public entities including, but not limited to, the State of Missouri, St. Charles County, and the City of St. Charles (collectively the "Released Parties").
  3. I understand and agree that this release will have the effect of releasing, discharging, waiving, and forever relinquishing any and all actions or causes of action that I and/or my child may have, whether past, present or future, whether known or unknown, arising from, resulting from, or in connection to the events. This release constitutes a complete release, discharge and waiver of any and all actions or causes of action that I and/or my child may have against the Released Parties, including but not limited to any claims for personal injury, property damage, or wrongful death and including but not limited to any injuries resulting from negligent actions or omissions. I understand and agree that this release will be binding on my heirs, my personal representatives, and my assigns.
  4. I agree that my child/guest is mentally and physically capable of participating in the KIDS BLOCK PARTY events and activities. I assume responsibility for his/her actions and safety, and realize that his/her inappropriate actions may result in personal liability. I understand that my insurance carrier or I will be financially responsible for any injuries suffered or caused. My child agrees to follow all rules, procedures and safety methods required of the activities. I understand that my child's privilege to participate in these activities may be revoked, suspended, altered, or modified if deemed necessary for his/her safety or that of other participants.
  5. I hereby give permission to the supervisors of the KIDS BLOCK PARTY events to consent to X-rays, tests, treatment, anesthetic, medical or surgical diagnosis or treatment, and necessary transportation for my child. In the event of an emergency, if I cannot be contacted I hereby give permission to the physician selected to administer treatment, including hospitalization for my child. I will pay the cost of any such medical procedures or treatment.
- I also agree to assume any and all financial responsibility for the participant's care while under the supervision of Spectra Venue Management and the Saint Charles Convention Center or its representatives. I release and waive, and further agree to indemnify, and hold harmless Spectra Venue Management and the Saint Charles Convention Center, its directors, employees, volunteers, and agents from and against, any claim which I, any other parent or guardian, any sibling, the participant, or any other person, firm or corporation may have or claim to have for any losses, damages, or injuries related to my child/guest's participation in these events.
6. I also give permission for the free use of my name, picture and voice at any broadcast, telecast, print account or any other account in any medium of this event. I voluntarily waive any right, cause of action, or demand of any kind that I and/or my child might have resulting from the use of such photographs and/or interviews.
  7. I also understand that neither I nor my child will receive any additional compensation for the use of my and/or my child's photograph and/or interview in promotional materials. Thus, by signing this document, I waive any rights to any compensation now or in the future.
  8. My child/guest will abide by all rules of conduct and safety set forth by Spectra Venue Management and the Saint Charles Convention Center for the events and activities at the Kids Block Party. Any inappropriate language, dress or other behavior (including exceeding the time limits of some events) will be grounds for disqualification from future events. It is up to the discretion of the supervisors and judges of the events as to what constitutes inappropriate behavior or dress.
  9. **I have carefully read this Waiver and fully understand its contents. I am aware that this is a release of liability and I sign of my own free will.**
